Councillor **Budarick** raised several issues. She suggested purchasing another sanitizing sprayer to lend out for the community. Ms. **Budarick** also questioned the status of conducting a municipal department audit, the review of the Integrity Commissioner Protocol, the Recreation By-Law, Indemnity By-Law, training, and the Work Place Harassment Policy. Council is not willing to review the IC Protocol at this time. The Acting Clerk-Treasurer will obtain more information on the Indemnity By-Law.

Councillor **Rutledge** expressed concerns with the condition of the Letterkenny Road as the shoulders are cracking in places. The Public Works Superintendent will contact the engineer for advice. Mr. **Rutledge** also asked if the municipality can send a letter to the Federal Government in regards to the new gun legislation.

Mayor **Keller** reported that EORN has entered into contract with Rogers Communications to improve cell service in rural areas.

Mr. Genrick reported that the Fire Department was successful in receiving a grant in the amount of \$4,900.00 from the Office of the Fire Marshall. The funds will be allocated for an online training portal and the purchase of iPads for the department.

ii. Resolution #3

"THAT the Township of Brudenell, Lyndoch and Raglan support the following resolution from the Township of Bonnechere Valley:

WHEREAS on September 1st, 2020 the Township of Bonnechere Valley passed a By-Law to permit extreme terrain vehicles and off-road vehicles in addition to all-terrain vehicles on all highways under the jurisdiction of the Corporation of the Township of Bonnechere Valley in accordance with the provisions of Ontario Regulation 316/03;

AND WHEREAS these changes to the existing list of off-road vehicles permitted on road by the Ministry of Transportation only apply to certain off-road vehicles that meet the requirements of Regulation 316/03;

AND WHEREAS these requirements do not include tracked vehicles. These off-road vehicles are not permitted on the highway:

AND WHEREAS the definition of "HIGHWAY" under Ontario's Highway Traffic Act "includes a common and public highway, street, avenue, parkway, square, place, bridge, viaduct or trestle, any part of which is intended for or used by the general public for the passage of vehicles and includes the area between the lateral property lines thereof." In other works, all that land (roadway, shoulder, ditches/land) from fence/property-line to fence/property line:

AND WHEREAS other tracked vehicles, such as snowmobiles, are permitted when directly crossing or, in specific circumstances, on the non-serviced portion of some highways

NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of Bonnechere Valley urges the Province of Ontario to amend the regulation to permit tracked off road vehicles in a similar manner to snowmobiles by permitting them to directly cross or, in specific circumstances, to travel on the non-serviced portion of some highways.

AND FURTHER that a copy of this resolution be forwarded to the Honourable Caroline Mulroney, Minister of Transportation, the Honourable Sylvia Jones Minister of the Solicitor General, the Honourable John Yakabuski, MPP Renfrew-Nipissing-Pembroke and all the municipalities within Renfrew County and the City of Pembroke."

WHERAS elected Officials of Municipality of Township are expected to be above reproach and to conduct themselves with integrity, truth, justice, honesty and transparency and courtesy,

AND WHEREAS there are people of dubious character wo have a criminal record, having been convicted of a Federal Offence, of any Federal Statues of Canada, but not limited to the Criminal Code or Narcotic Control Act, Who are currently on Council of a Municipality or have let their name stand for election for Mayor, Reeve or Councillor as a municipal candidate

NOT WITHSTANDING the provisions of the Ontario Human Rights Code

THEREFORE BE IT RESOLVED that the Corporation of the Township Pickle Lake hereby supports the Township of Conmee as they lobby the Provincial Government to amend the Municipal Act and Municipal Elections Act as may be, so that people with a criminal record who have not had their record cleared from the RCMP Data Base by order of the Governor General of Canada be prohibited from becoming a candidate in municipal elections.

AND THAT an elected local government official be disqualified from office upon conviction of a serious criminal offence and must resign.

AND THAT the Council direct the Clerk to send a copy of this resolution to the Ontario Premier Doug Ford, NOMA, Attorney General Doug Downey, Solicitor General Sylvia Jones, Minister of Municipal Affairs Steve Clark, AMO, ROMA Our local MPP and all Ontario Municipalities."

WHEREAS the Government of Canada introduced Bill C-45 (the Cannabis Act) to create the foundation for a comprehensive national framework to provide restricted access to regulated cannabis, and to control its production, distribution, sale, importation, exportation and possession;

WHEREAS the police have not been given lawful authority to lay charges under the Cannabis Act to appropriately respond to violations of Health Canada Registrations and Licenses;

WHEREAS there is no direct communication or dedicated effort to provide a communication channel between Municipal government staff or Police Agencies for dealing with Health Canada Registrations and Licenses;

WHEREAS the Township of Brock had not been consulted by Health Canada prior to the issuance of licenses for properties not in compliance with municipal zoning by-laws; in the future

BE IT RESOLVED THAT the Township of Brock requests that Health Canada;

- 1. Require Federal licenses and Registrations for Designated Growers to conform to the local zoning and control by-laws;
- 2. Ensure local authorities are provided with notification of any license issuance, amendment, suspension, reinstatement or revocation within their region;
- 3. Provided dedicated communication with local governments and Police services;
- 4. Provide lawful authority to Police agencies to lay charges when registered or licenses operations grow in excess of their registration or licence through Health Canada and
- 5. Provide enforcement support and guidance to local municipalities for dealing with land use complaints relating to Cannabis.

AND FURTHER BE IT RESOLVED THAT The Township of Brock will forward this motion by email to the following partners: All municipalities in Ontario, the MP and MPP of Haliburton-Kawartha Lakes-Brock, the Minister of Agriculture, Food and Rural Affairs, the Minister of Agriculture and Agri-Food, and the Durham Region Police Services with the request that the Federal Government enact legislation to better support local governments with land use management and enforcement issues as they relate to Cannabis Production and Processing. Carried.

The Council of the Corporation of the Municipality of West Grey hereby supports the resolution of the Municipality of Grey Highlands dated January 22, 201 wherein they call on the Province of Ontario to review the seven recommendations of AMO to investigate the following municipal insurance issues, as insurance premiums will soon be out of reach for many communities:

- 1. The provincial government adopt a model of full proportionate liability to replace joint and several liability.
- 2. Implement enhancements to the existing limitations period including the continued applicability of the existing 10-day rule on slip and fall cases given recent judicial interpretations and whether a one-year limitation period my be beneficial.
- 3. Implement a cap for economic loss awards
- 4. Increase the catastrophic impairment default benefit limit to \$2 million and increase the third-party coverage to \$2 million in government regulated automobile insurance plans.
- 5. Assess and implement additional measures which would support lower premiums or alternatives to the provision of insurance services by other entities such as non-profit insurance reciprocals.
- Compel the insurance industry to supply all necessary financial evidence, including not limited to, premiums, claims and deductible limit changes which support its own and municipal arguments as to the fiscal impact of joint and several liability.
- 7. Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General and

THAT this motion be provided to the Premier of Ontario, Minister of Finance, Attorney General of Ontario, MPP of Bruce-Grey-Owen Sound and all municipalities of Ontario."
