Resolution #11

# Moved by Iris Kauffeldt, sec. John Rutledge

### Whereas:

Councillor Budarick was found to have breached the *Municipal Conflict of Interest Act* and her seat Ordered to be vacated for the remainder of this term of Council by Justice James in his decision dated November 22, 2021 with an effective date of November 28, 2021;

Councillor Budarick has appealed the decision of Justice James and brought an urgent motion to stay the decision vacating her seat. The motion was originally heard November 26, 2021;

The Integrity Commissioner opposes the stay and has instead suggested that Council be Ordered not to fill the vacancy created by Councillor Budarick's removal until such time as the appeal has been heard or finally disposed of;

A temporary stay of the decision to vacate was issued by Justice Bell on November 26, 2021, until December 3, 2021 when Councillor Budarick's motion for a stay will be heard on its merits;

Justice Bell raised a concern during the motion hearing on November 26, 2021, that the Township did not have notice of the proceedings and a copy of her endorsement has been provided to and reviewed by the Townships' Council;

Council has been provided with a copy of the notice of appeal and all of the motion materials filed with the Court to date in relation to both

Councillor Budarick's appeal and with respect to the motion to stay the Order of Justice James;

Council has considered the serious nature of the breaches by Councillor Budarick of the *Municipal Conflict of Interest Act* set out in the Integrity Commissioner's report and found by Justice James; and

The Township is concerned that should Councillor Budarick continue to participate on Council pending the determination of her appeal, Council's decisions during that period will be subject to challenge if her appeal is unsuccessful because that result would see her seat having been vacated while she purported to occupy it.

Therefore, BE IT RESOLVED THAT:

Council for the Township confirms that it has received service of the notice of appeal, notice of motion for a stay, the Integrity Commissioner's responding materials and the endorsement of Justice Bell;

Council for the Township confirms that they oppose the motion for a stay;

Council for the Township takes the position that a vacancy created by a judicial Order under section 259(1)(f) of the *Municipal Act, 2001* may be subject to such terms as may be imposed by the Court, including that the court may Order that the vacancy not be filled until such time as any appeal thereof is finally heard and determined.

Moreover, Council for the Township takes the position that section 11(2) of the *Municipal Conflict of Interest Act* provides the Divisional Court with broad discretion to make any Order that ought to be made at first instance, including modifying the Order being appealed from on a stay motion to protect the vacancy until the appeal is finally heard and determined.

Council for the Township hereby commits to take notice of, and be bound by, any Order prohibiting the Township from filling Councillor Budarick's vacancy until her appeal to the Divisional Court is finally disposed of;

Council for the Township consent to be bound by an Order amending or clarifying Justice James' Order as part the Court's inherent jurisdiction pursuant to the provisions of the *Courts of Justice Act* to issue a stay of an Order subject to such terms as the Court may impose;

The Township supports any form of an order that would prohibit Councillor Budarick from participating in Council meetings as a Member of Council."
