The Fire Chief reported that he spoke to the Fire Chief from Killaloe, Hagarty & Richard regarding fire calls in the Brudenell area. The Killaloe, Hagarty & Richard Fire Department will offer mutual aid if they have the required resources.

v. The Fire Chief informed Council that two pumper trucks have been removed from service. Presently, there is a pumper truck at the Hardwood Lake Fire Hall and at the Quadeville Fire Hall. The Brudenell and Palmer Fire Halls have tanker trucks only. Council discussed purchasing the 1994 pumper truck from Asphodel Fire Trucks Ltd. and agreed not to purchase the truck. Council discussed purchasing a new pumper truck and staff was directed to prepare the tender documents.

The training for the firefighters was discussed. The training will be increased to two sessions a month. The bunker gear has also been inspected and some pieces will need to be sent away for repair.

The Master Fire Plan was also discussed. Council was strongly opposed to tendering for a consultant to draft the plan. Council wants the Fire Department to draft the plan.
