1. The Meeting was called to order by Reeve, **Norman Lentz**.

2. PECUNIARY INTERESTS – None

3. DEPUTATIONS

i. Lillian Gruntz

Mrs. Gruntz was not in favour of the compressed air foam system and was concerned about the municipality going into debt to pay for the system.

ii. Lionel Ownsworth

Mr. Ownsworth had done research on the compressed air foam system and had spoken to other Fire Departments. He presented his findings to Council.

iii. Don Peddar

Mr. Peddar felt that a quicker response time was needed rather than a new system.

iv. Barry Fields

Mr. Fields informed Council that 600 residents had signed a petition requesting that the current system of operation for the Fire Department be retained.

v. Rob Van Vliet

Mr. Van Vliet felt that the Fire Department needed a new system. He was in favor of purchasing the compressed air foam system for the Fire Department because DZ licenses are not required, if it would be easier for training purposes as all trucks would be identical and there would be less maintenance on new trucks.

vi. Jordan Genrick & Lonnie Liedtke

Mr. Genrick & Mr. Liedtke presented a Five Year Plan for the Hardwood Lake Fire Hall.
