1. The meeting was called to order by Mayor **Keller**.

i. Public Works Superintendent

The public works report was accepted as presented.

The box and frame on the 2006 International has been painted. Another Letterkenny Road sign has gone missing. The winter sand has been completed.

An inspector from MOECC inspected the Brudenell Waste Site and Lyndoch Transfer Station. A report will follow.

Mr. Behm received a call from a resident on Sacred Heart Road about a culvert on his property that has been damaged by log trucks. The Clerk will confirm if the culvert is on the municipal portion of the road or if it is on a MNR Forestry road.

Killaloe CRC applied on behalf of the municipality for funding to purchase small appliances and/or kitchen equipment. These funds will help with the kitchen renovations, which are set to begin once the plans have been finalized.

Training from the OFMEM will take place December 11, 2019. Council members and senior staff will attend.

Council discussed the quotes provided by the Clerk to survey Heins Road. Mr. Milosavljevic was present, and he still believes it is the responsibility of the township to survey the road.
