

At its meeting of October 21, 2025, the Council of the Town of Bradford West Gwillimbury adopted the enclosed motion calling on the Governments of Canada and Ontario to remove the federal and provincial portions of the HST from new homes purchased as primary residences.


This measure would extend the relief already provided for purpose-built rental housing to families seeking to buy their first home. It represents a practical, immediate step toward improving affordability and supporting new housing supply.

For an average new home in our community, the 13 percent HST adds tens of thousands of dollars to the purchase price, a burden that directly undermines our shared goal of making homeownership affordable for working families and seniors. Removing that tax would provide meaningful relief.


Bradford West Gwillimbury is one of Ontario's fastest-growing municipalities, investing heavily in growth-related infrastructure while working to keep housing within reach. We urge both levels of government to work together on this change as part of a broader strategy to make homeownership attainable again for young Canadians. Simply put, cutting taxes in this way will help make life more affordable.

We would welcome the opportunity to contribute to any federal-provincial review of housing-related taxation and policy tools that can help deliver more affordable homes.

**Re: Solve the Crisis and Winter Homelessness Program Support**

The following resolution was passed by Ajax Town Council at its meeting held on November 17, 2025:

Whereas, we are approaching the cold winter months and the number of people experiencing homelessness in Ajax and Durham Region continues to rise drastically, with more than 1,000 people on Durham Region's by-name list as of August, including specifically 200 people in Ajax seeking support to change their housing status<sup>1</sup>; and

Whereas, in September 2024, Ajax Council passed a motion to support Ontario Big City Mayors (OBCM) [SolveTheCrisis.ca](http://SolveTheCrisis.ca)<sup>2</sup> campaign requesting that the provincial and federal governments take immediate action to solve the homelessness and mental health crisis gripping our communities; and

Whereas, while the provincial government has provided support for new programs such as Homeless and Addiction Recovery Treatment Hubs (HART Hubs), it does not adequately address the growing crisis and the financial and social impact on municipalities and regions; and

Whereas, according to the Association of Municipalities of Ontario, municipalities are providing [51.5% of the total reported homelessness program funding across all three levels of government](#), making a significant financial impact on municipal budgets<sup>3</sup>; and



Whereas, OBCM recently passed a motion at their October Meeting re-iterating the need for provincial support in addressing this crisis by allocating more funding to programs that address chronic homelessness; and

Therefore, be it resolved:

1. That Ajax Council reconfirms their support of the Solve the Crisis Campaign and calls on Ajax residents to join us in appealing to the provincial and federal governments for support by visiting [SolveTheCrisis.ca](http://SolveTheCrisis.ca); and
2. That Ajax Council asks that the provincial government to take action on the requests of the Solve the Crisis Campaign that have not been fully addressed including:
  - a. Appoint a responsible ministry and Minister with the appropriate funding and powers as a single point of contact to address the full spectrum of housing needs as well as mental health, addictions and wrap around supports.
  - b. This single Minister must strike a task force with sector representatives including municipalities, health care leaders, first responders, community services, the business community, and the tourism industry to develop an Ontario Action Plan.
  - c. Provide municipalities with the tools and resources to transition those in encampments to more appropriate supports, when deemed necessary.
  - d. Commit to funding the services our unhoused population needs, community by community, to fill in gaps in the system.
  - e. Invest in 24/7 community hubs or crisis centres to relieve pressure on emergency departments and first responders; and
3. That Ajax Council asks that the provincial government prepares a 2025/2026 winter homelessness response plan to help municipalities ensure that we can keep our unsheltered residents who are sleeping outdoors with the services they need to keep them safe in colder weather; and
4. That a copy of this resolution be sent to Doug Ford, Premier of Ontario, Rob Cerjanec, MPP for Ajax, local MPPs across the Region of Durham, Durham Regional Council, all Ontario Municipalities, Ontario Big City Mayors (OBCM).





**WHEREAS** First Nations of Ontario women continue to be underrepresented at decision-making tables, despite significant leadership: as of recent reports, women hold over 35% of elected Chief positions in First Nations of Ontario, and significantly more leadership positions within community organizations, health, and education boards - positions that bring deep experience in balancing development with community well-being; and

**WHEREAS** The legacy of natural resource development in Northern Ontario has contributed to environmental degradation and social disruption, including clear links to the ongoing crisis of Missing and Murdered Indigenous Women, Girls, and Two-Spirit People (MMIWG2S); and

**WHEREAS** The National Inquiry into Missing and Murdered Indigenous Women, Girls, and Two-Spirit People (MMIWG2S) identified extractive industries as a key contributor to increased vulnerability to violence, especially in isolated development zones lacking oversight and safeguards; and

**WHEREAS** The Province of Ontario has an obligation to ensure that economic growth is not achieved at the expense of women's safety, human rights, or environmental integrity.

1. Ensure that women, Two-Spirit, and gender-diverse people—particularly from Indigenous and Northern communities—are actively engaged at the forefront of all planning, consultation, and implementation processes under Bill 5, from concept to completion;
2. Establish a dedicated Ministerial role or mandate for overseeing and safeguarding women's rights, safety, and economic opportunity throughout the resource development process, including authority to apply gender-based impact assessments to proposed projects;
3. Mandate gender-based and intersectional impact assessments be carried out on all developments enabled by Bill 5, particularly with regard to safety, housing, transportation, healthcare access, and cultural impacts on women and girls;

### Great Lakes Coastal Resiliency Study

Hosted a high-impact policy roundtable in Washington D.C., led by the Mayors Commission on Coastal Resilience, to strengthen municipal engagement with the Great Lakes Coastal Resiliency Study. This event featured Major General Mark C. Quander, Commander of the Great Lakes and Ohio River Division of the U.S. Army Corps of Engineers, alongside other key project partners, resulting in a renewed commitment to collaborative resilience planning and actionable support for Great Lakes communities.



### Great Lakes Lead Pipes Partnership at the Water Summit

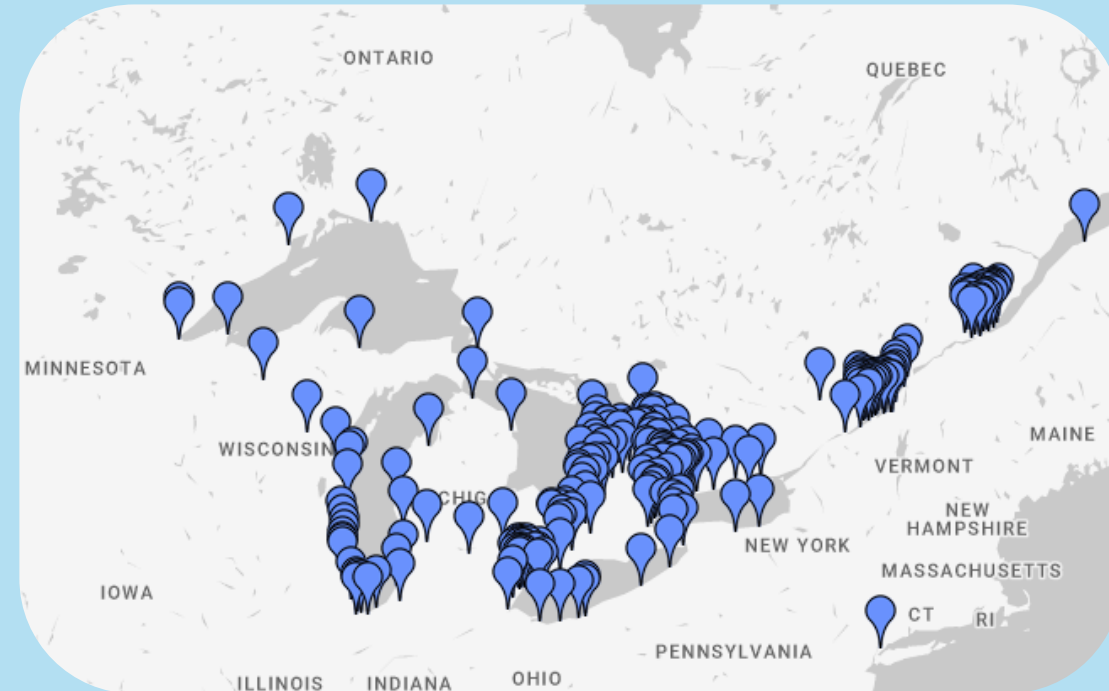

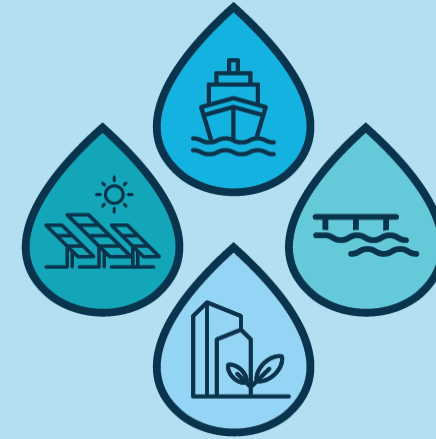

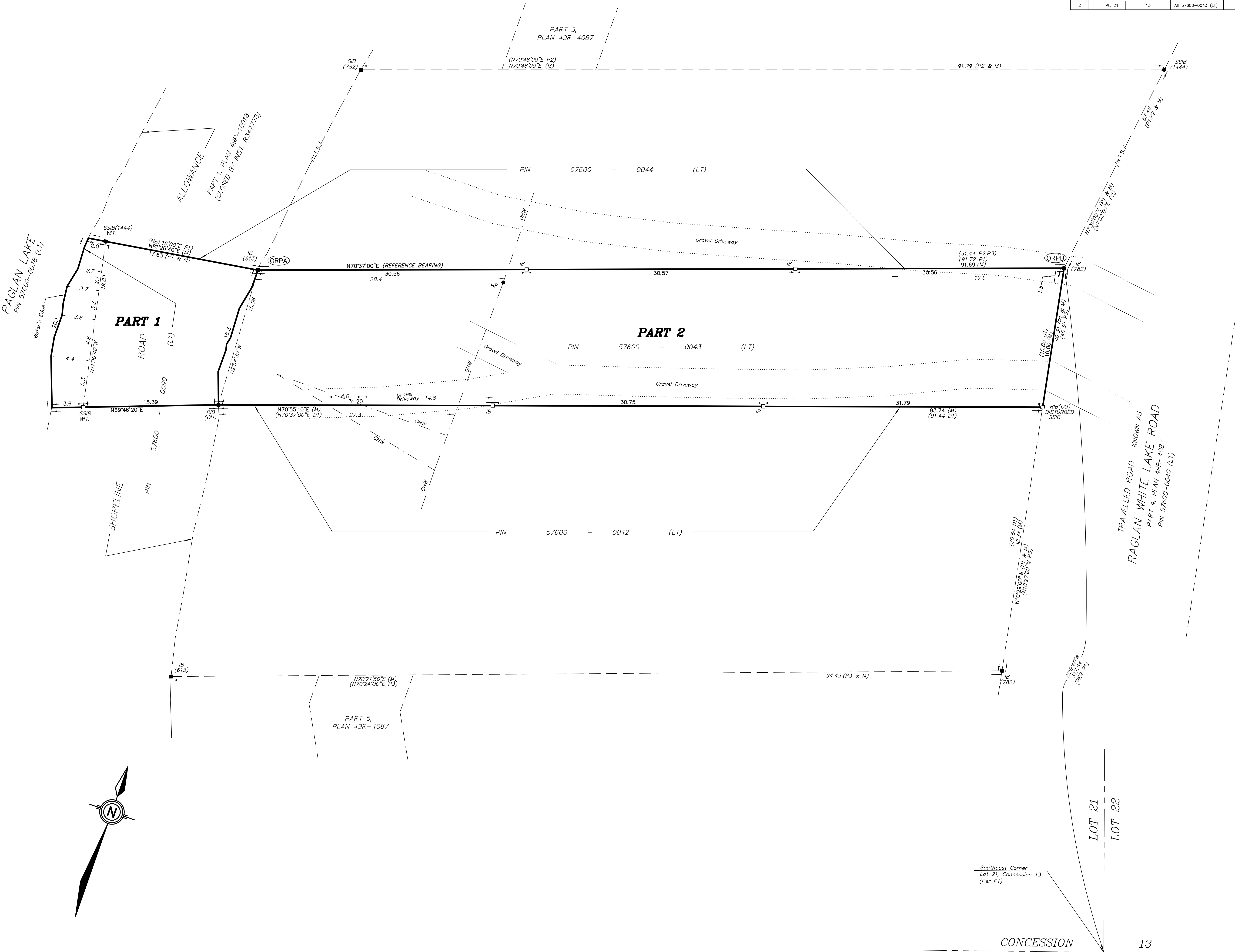

**BY-LAW NO. 2025-46**

Being a By-law to adopt an Emergency Management Program and Emergency Response Plan and to meet other Requirements under the *Emergency Management And Civil Protection Act*

WHEREAS under the *Emergency Management and Civil Protection Act*, R.S.O. 1990, c.E.9 (the “*Act*”), as amended, and Ontario Regulation 380/04 (the “*Reg*”), as amended, every municipality in the Province of Ontario is required to:

- Develop and implement an emergency management program, which shall consist of:
  - An Emergency Response Plan;
  - Training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
  - Public education on risks to public safety and on public preparedness for emergencies;
  - Identification and assessment of hazards and risks to public safety, including identification of critical infrastructure; and
  - Any other element required by the standards for emergency management programs set under the *Act* or by Emergency Management Ontario;
- Designate an employee of the municipality or a member of the council as its Community Emergency Management Program Coordinator (CEMC);
- Establish an Emergency Management Program Committee;
- Establish a Municipal Emergency Control Group (MEGC);
- Establish an Emergency Operations Centre (EOC) to be used by the Municipal Emergency Control Group in an emergency; and
- Designate an employee of the municipality as its Emergency Information Officer (EIO);

AND WHEREAS is prudent that the emergency management program developed under the *Act* be in accordance with international best practices, including the five core components of emergency management: prevention, mitigation, preparedness, response and recovery;

AND WHEREAS the purpose of such a program is to help protect public safety, public health, the environment, critical infrastructure, and property during an emergency and to promote economic stability and a disaster resilient community;

NOW THEREFORE the Council of the Corporation of the Township of Brudenell, Lyndoch and Raglan hereby enacts as follows:



## **Emergency Management Program**

1. An Emergency Management Program for the municipality will be developed and reviewed annually by the Emergency Management Program Committee consistent with and in accordance with the *Act* and *Reg* and international best practices, including the five components of emergency management, namely: prevention, mitigation, preparedness, response and recovery. And such program shall include:
  - a. Training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
  - b. Public education on risks to public safety and on public preparedness for emergencies; and
  - c. Any other elements required by the standards for emergency management set under the *Act* or by Emergency Management Ontario.
2. The Emergency Management Program shall be consistent with the objects of protecting public safety, public health, the environment, critical infrastructure and property, and to promote economic stability and a disaster-resilient community.

## **Emergency Response Plan**

3. The Emergency Response Plan, which has been developed in accordance with the requirements of the *Act* and *Reg* and international best practices, and which is attached hereto as Appendix “A” is hereby adopted (the “Plan”).
4. The Plan shall be reviewed annually by the CEMC and the Emergency Management Program Committee. The CEMC is authorized to make such administrative changes to the Plan as appropriate to keep the Plan current, such as personnel, organizational and contact information updates. Any significant revision to the body of the Plan shall be presented to Council for approval.
5. When an emergency exists but has not yet been declared to exist, Township employees and the Municipal Emergency Control Group may take such action under the Plan as may be required to protect property and the health, safety and welfare of the inhabitants of the Township.

## **Community Emergency Management Coordinator**

6. The Clerk-Treasurer is hereby appointed as the primary community emergency management coordinator (the “CEMC”) responsible for the emergency management program for the Township including annual maintenance of the Plan, training, exercises, public education and such duties and responsibilities as outlined in the *Act* and *Reg*.
7. The Fire Chief/Operations Manager is hereby appointed as alternate CEMC to act in place of the primary CEMC in his/her absence.

## **Emergency Management Program Committee**

8. The persons from time to time holding the following positions in the municipality, or their designates, shall be members of the Emergency Management Program Committee:
  - a. Clerk-Treasurer;
  - b. CEMC and Alternate CEMC;
  - c. Fire Chief/Operations Manager;
  - d. Deputy Clerk;
  - e. Public Works;
  - f. Mayor or Deputy Mayor.
9. The CEMC is hereby appointed as chair of the Emergency Management Program Committee.
10. The Emergency Management Program Committee shall advise Council on the development and implementation of the municipality's Emergency Management Program and shall review the program annually.

## **Municipal Emergency Control Group**

11. The persons from time to time holding the following positions in the municipality, or their designates, shall be members of the Municipal Emergency Control Group (MECG):
  - a. Head of Council – Mayor, or designate;
  - b. Operations Officer – Clerk-Treasurer;
  - c. Community Emergency Management Coordinator (CEMC) or alternate;
  - d. Liaison Officer – Deputy Clerk;
  - e. Safety Officer – CEMC or alternate;
  - f. Operations Manager;
  - g. Fire Chief or designate;
  - h. Emergency Information Officer;
  - i. Public Works;
  - j. Others as required (example: County Officials, OPP, Utilities Reps, etc.).

The MECG shall meet annually for training, participate in an annual exercise, and be available 24/7 for notification and activation.

## **Emergency Operations Centre**

12. A primary and an alternate Emergency Operations Centre have been established for use by the MECG in an emergency and with the appropriate technological and telecommunications systems to ensure effective communication in an emergency. The locations of the Emergency Operations Centre(s) are identified in the Plan.

## **Emergency Information Officer**

13. The Deputy Clerk is hereby appointed as the Emergency Information Officer for the municipality to act as the primary media and public contact for the municipality in an emergency.

## **Administration**

14. The Plan shall be made available to the public for inspection and copying at the Brudenell, Lyndoch and Raglan Municipal Office, 42 Burnt Bridge Road during regular business hours and on the Township's website [www.blrtownship.ca](http://www.blrtownship.ca).
15. The Plan, or any amendments to the Plan, shall be submitted to the Office of the Fire Marshall and Emergency Management as identified in the *Act*.
16. That Appendix "A" is deemed to form part of this by-law.
17. That By-law No. 2004-11 be hereby repealed.

3. This bylaw takes effect on the day of its final passing.
